1. Competition Dates

- Opens: **9am Monday 14 September 2026**
- Closes: **5pm Friday 16 October 2026**

2. Eligibility

- Open to all Primary School aged children (Kindy to Year 6) residing in the electorate of Pearce. (Find your electorate: <https://electorate.aec.gov.au/>)
- One entry per child only.
- Entry to this competition is free of charge; no purchase is necessary.
- Employees and contractors of Tracey Roberts MP's electorate office, and their immediate family members, are not eligible to enter.

3. How to Enter

- Entrants should colour in the Christmas illustration on the Tracey Roberts MP Christmas Card Competition sheet, available to download at <https://www.traceyrobertsmp.com.au/community/christmas-colouring-in-competition/>
- Complete all details on the form including the full name of parent/guardian, address, contact number, and email address.
- Parent/guardian signature is required and constitutes consent for the child's participation and use of their entry as outlined in these terms.
- Submit completed entry by either:
 - Delivering to the electorate office at 2/23 Ocean Keys Bvd, Clarkson WA 6030 before Friday 16 October 2026, OR
 - Notifying the office that your school will be participating for collection on Thursday 15 or Friday 16 October 2026
- Entries deemed illegible or incomplete will be considered invalid.

4. Permissions and Privacy

- By entering this competition, you give the Promoter permission to use entrants' details for promotional and news service updates via email. You may opt out of future communications by contacting the office.
- By entering, you consent to the winning illustration being featured on the annual Christmas card distributed to parliamentary colleagues and Pearce constituents.
- Personal information will be handled in accordance with the Australian Privacy Principles and retained only as long as necessary for competition and promotional purposes.

5. Entry Conditions

- The Promoter is not responsible for entries that are not received or are received late.
- Entries must be the child's own colouring work, on theme, and include a completed application form with parent/guardian signature.
- All entries will become the property of the Promoter and will not be returned to entrants.

- The Promoter reserves the right to disqualify, at its sole discretion, any entry it reasonably believes is not the entrant's own original work or that otherwise breaches these terms.

6. Judging

- Entries will be judged by Tracey Roberts MP.
- The judges' decision is final, and no correspondence will be entered into concerning the granting of prizes.
